COMMENTS:

The landfarm that is currently in place on the SJ Warren Site has been recently sampled and it appears that the chemicals of concern (COC) have decreased to below the COGCC Table 910-1 standards in most cases. See attached table. TPH-DRO appears to be the primary COC that is greater than the Table 910-1 standard of 500 mg/kg. With continued treatment of the soil in the landfarm, the TPH-GRO concentrations should continue to lessen. Continued tilling of the in place landfarm once a week beginiing in the spring with analytical composite samples collected every two months is the scheduled treatment for the SJ Warren landfarm. Communication of the analytical results and progress of the landfarm treatment will be submitted to the COGCC no later than 45 days after the analytical sample results have been received. Please find a cover letter and analytical tables attached.
