Javernick Oil received your letter including a Notice of Alleged Violation (NOAV), No. 200437826 issued on October 27, 2015, by Diana Burn, Representative of the State of Colorado Oil and Gas Conservation Commission (COGCC). A second notice of the NOAV No. 200437826 was sent on December 28, 2015 by David Beckstrom, COGCC Enforcement Officer, via electronic mail to the address javernick1@bresnan.net (Javernick Oil). A third notice was sent on January 4, 2016 by Peter Gowen, COGCC Enforcement Supervisor, via electronic mail to javernick1@bresnan.net (Javernick Oil), kaulin.waldner@dewpointwest.com (Dewpoint West LLC), and tbm3040@gmail.com (Javernick Oil).

In accordance with COGCC Rule 522.d.(2), this letter serves as the Answer to NOAV No. 200437826. A description of the corrective actions are listed below.

Alleged violation of Rule 308A:

- Drilling Completion Reports, Form 5 Doc. No. 400938268 (API No. 05-043-06196-00) and Form 5 Doc No. 400938369 (API No. 05-043-06196-01) were submitted on November 17, 2015 via Eform. By request of Dewpoint West on January 5, 2016, Chuck Romanchock returned the forms to draft for modifications and the forms will be resubmitted expeditiously.

Alleged violation of Rule 308B:

- Javernick will submit a complete and accurate Form 5A Completed Interval Report promptly after resubmittal of the Drilling Completion Reports.

Alleged violation of Rule 309:

- Javernick will submit complete and accurate Form 7 Monthly Operations Reports for every month dating back to August 2012 upon completion of the Completed Interval Report.

The above order of actions was discussed between Peter Gowen and myself, on January 5, 2016 to determine the ideal order to submit the required forms. This order of corrective actions should prevent any data conflicts when entered into the COGCC records database.
