Hi Rick,

That is correct, the leak occurred on a line which leads into the tank battery where produced water is stored before being injected down the Simba 1-06 well. If you are ok with making the changes then please do so.

In addition, after talking with our production department today, the coordinates of the spill are slightly different than what I indicated on the initial report. The spill occurred closer to 40.955719, -104.362640, which is still on the Simba wellpad location but closer to the west corner.

The landowner and Weld County were both notified of the spill on 1/1/2016.

Thanks for the assistance and please let me know if you have any additional requirements. I will be submitting the supplemental report this week, and we will get soil samples collected.

Steve,

COGCC is reviewing the Initial Spill Report for the Simba 1-6 disposal location. Please review the following suggested changes and let me know if you agree with me changing the information on the form:

1. The spill description sounds like the release occurred on a line at the tank battery, the disposal well itself. Therefore, the Facility Type should be changed from "WELL" to "TANK BATTERY".
2. The spill should be related to the Location ID where the spill occurred, not the API of the well. The Reference

Location should be changed from API 05-123-31035 to Location ID 415149.

If you agree, I can make the changes to the form for you.
