Good Morning, Erin and Kaleb,

After discussion with Jane Stanczyk, I have confirmed that we are adding a COA to this well's APD to require that an open hole log with gamma ray be run in the vertical portion of this wellbore from kickoff point to setting depth of the surface casing.

A COA can be added to an approved APD by alerting the operator with an email and putting this email in the well file.

I understand that Extraction has every intention of running this open hole log and will make every effort to do so. If problems are encountered during the drilling and attempted logging of this well, please contact me or Diana Burn immediately to alert us to your issues. It's better to alert us at the time of drilling rather than waiting to submit a Form 5 with a comment that no open hole log was run.

You have indicated that this is the only well planned to be drilled as a horizontal J sand well on this pad. The Fairview #1 is permitted as a horizontal J sand well but will not be drilled past the surface casing setting depth. Please remember to submit a Form 5 preliminary for this well if drilling does not resume in 90 days from date of setting surface casing.
