#### COMMENTS:

1. Run and set a CIBP down at 5310' (or deeper if we can) and set 2 sks. cement on top. We have gotten the top of the 5-1/2" casing in good enough shape we should be able to run the CIBP down through the casing now.
2. Load the casing with lease water.
3. Back off the first joint of 5-1/2" casing (must have fluid in the hole to shoot off the charge to back off the casing)
4. Pull out the joint of 5-1/2" casing.
5. Run a new joint of 5-1/2" casing.
6. Install valve on top and pressure test casing.
7. Send in Form 42 to schedule and run MIT if casing tests good; if casing does not test good, submit Form 6 to P&A the well.
