As discussed with John Noto on January 26, 2016, the purpose of this Sundry is to depict an expanded disturbed area on the Location Drawing to accommodate staging of haybales and sound source panels for noise mitigation and source level studies during completion activities. This location has been constructed, drilled, but not completed. All construction was completed as approved by the COGCC. There will be no surface disturbance conducted within the expanded staging area depicted on this drawing. This expanded area will not be graded, maintaining its current surface grade. The only activity beyond staging conducted within this area will be cleanup activities after the completion activities are conducted and mitigation materials are removed. This new drawing is being provided at the direction of the COGCC OGLA staff for reference and is not meant to request additional surface disturbance. Approval to utilize the depicted staging area by February 5th, 2016 is crucial to Kerr McGee's completions schedule and obtaining valuable data for future adjacent property mitigation.
