COMMENTS:

WPX Energy requests approval to change the frac plan for the new wells on the RU 21-8 pad. Because of current drilling activity on the RU 34-6 pad WPX would like to keep the RU 34-6 pad open and use it as a remote frac pad for the wells on the RU 21-8 pad. Three (3)-4.5" temporary surface frac lines will be installed along existing roads from the RU 34-6 pad to the RU 21-8 pad. Water will be supplied to the RU 34-6 via existing infrastructure. Water will come from Pit 11-7-793. This change will allow the RU 23-5 pad to be placed into interim reclamation summer/fall of 2015.
