Rick,

Per our conversation yesterday, please find comments to your email.

1. PDC has identified a water well to be 43 feet from the release. This water well appears to be Division of Water Resources permit #15931. According to the DWR records this water well is located on the edge of the section line, approximately 800 feet from the release. On future spills, please further evaluate the locations of water wells that appear to be within 1/8 mile of a release and provide supporting comments in the "Additional Spill Details" box to support the data listed under the distance to nearest receptor.
 - a. *PDC acknowledges the need to evaluate water wells that appear to be within a 1/8 mile radius of reportable release locations and provide supporting comments on spill details and corrective actions taken.*

2. On the Corrective Actions Report, the Root Cause is described as a failure of a casing valve on the wellhead, but does not give an explanation as to why the valve failed. Explaining why the valve failed will get to the root cause. Please provide a more detailed root cause and corrective action for this release.
 - a. *Valve failure resulted from water freezing within the center of the closed ball valve. The freezing liquid expanded outward, rupturing the O-rings which form seals around the ball valve, allowing liquid to escape. To prevent similar failures, ball valves only will be shut in once they are free of liquids.*
