Document #200364647 (9/20/2012) and subsequent 9/21/2012 COGCC inspection recommended site inclusion on PRAW list based on "significant erosion". This COGCC inspection (2/12/2016) notes erosion on the access road to the southwest of the well pad that is down a slope (see attached photos). Well pad location and access road to the east are satisfactory to the current landowner.

Document #441131, dated 7/20/1994, is correspondence from the previous landowner, Arnold R. Coggins, that released HABCO from any "surface restoration" and the bond was released on 11/8/1999 (see inspection #500141521, 7/27/1994).

An "Orphan Location Project Summary" registration form was completed by Inspector Sherman on 2/18/2016 to request the site be included in the Plugging, Reclamation and Abandoned Well program (PRAW).
