The Operator has reviewed with its staff the importance of reviewing all Conditions of Approval for all wells drilled and has especially stressed the importance of reviewing Conditions of Approval for all wells and pads when multiple pads are located in close proximity. In particular, the Operator will review all logging requirements in a multi-disciplinary pre-drilling pad meeting and the regulatory group will provide regular reports to Drilling and Completions confirming logging requirements.

The Operator will run a Cased Hole Neutron Log in conjunction with CBL Logs prior to completions operations on one well on this pad. This log will be noted on Preliminary Form 5 for each well on the pad and the CNL will be attached to the Final Form 5 of the well it is run on and noted on the Final Form 5's for the other wells on this pad. Estimated date for running the CNL is 3rd quarter/2017.
