COMMENTS:

Request an Exemption from Rule 325c.1 for the Lyons, L. Satanka, Wolfcamp, Amazon & Council Grove Formations for the NGL C3B (API # 05-123-42811) well due to its proximity to the NGL C3A (API # 05-123-31735) and its high water TDS analysis results. The C3B is a vertical well and the C3A is directional with the injection formations separated by aprx. 6559'. The NGL C3A well acquired water samples from the formations as listed above and no samples obtained had a TDS less than 11,000 mg/L. A Correlation spreadsheet is attached showing the details of the TDS values in the NGL C3A correlated to the same formations of the planned NGL C3B. An updated WB Diagram for the NGL C3B is attached as well as a Spreadsheet with Formation Correlations for the C3A & C3B. Spud of the NGL C3B will probably occur on 3/2/2016.
