COMMENTS:

Regarding a release that occurred on the Valley Farms B location on January 26, 2013 under the previous operator, Antero Resources, and reported via Form 19 on February 4, 2013 (Spill Tracking #2231929). It was requested that a Site Investigation & Remediation Workplan (Form 27) be submitted for any impacts that may be present. Ursa Operating Company LLC (Ursa) acquired the asset on April 1st, 2013, at which time a Form 27 was submitted on April 14, 2013 and approved on April 17, 2013, assigning a remediation # 7726. Site investigation activities began on June 12, 2013 by completing five (5) boreholes around the outside of the lined secondary containment, focusing primarily on where the hole in the liner had been discovered. The attached summary of findings report will outline the site characterization process.

As no impacts were observed in the attached site investigation report, Ursa is requesting closure of this release (Rem# 7726) and no further action be issued.
