The B&V Pad (Loc ID 440634) has been constructed and is scheduled for drilling operations beginning in August 2016 (subject to change). Ursa would like to leave the 24 conductors in place to support our drilling schedule. The 16" conductor pipe was set on 01/29/16 at a depth of 59' with 100 sacks of cement.
