Please be advised that this well was plugged and abandoned by Rippy, Inc. in June, 1997. The following procedure was witnessed by BLM personnel:

- 1) Perforations were shot @ 5300' and squeezed with 70 sx. Cement was tagged @ 5060'
- 2) Casing was cut and pulled from 2381' - surface.
- 3) A 30 sk plug was placed from 2260' and tagged @ 2170'.
- 4) A 90 sk plug was placed from 800'-500'.
- 5) A 17 sk plug was spotted from 35' to surface.

Upon inspection and approval by BLM personnel, the location will be reclaimed and rehabbed.

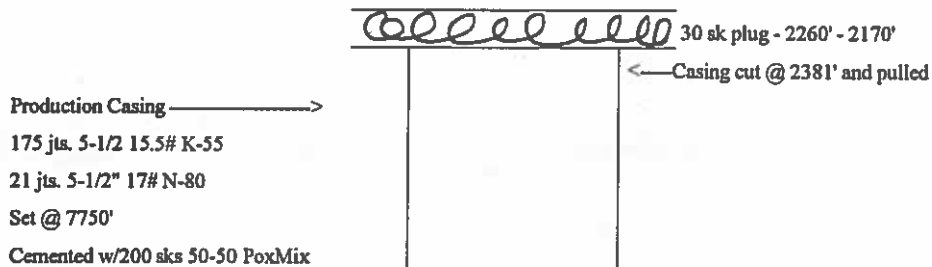
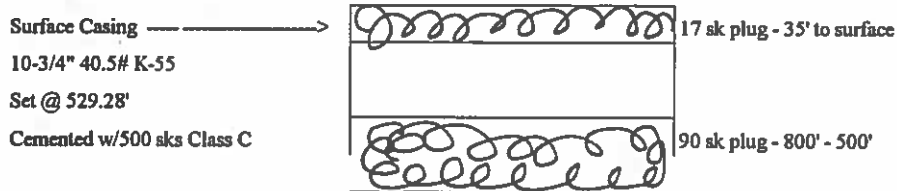
