COMMENTS:

Ward Petroleum requests to flare this well while a gas and oil pipeline are laid to the wellsite, Ward requests flaring to be granted until January 9th, 2017 similar to the Anderson 19-1-10HC. Ward Petroleum is installing their own gas pipeline to the area and requests further time to receive ROW, permits, and construct. Ward will utilize Pioneer Energy's mobile alkane separator to knock out the NGLs for sale and to reduce the potential dry flare gas volume. Ward and Pioneer Energy continue to work on selling the dry gas to heat homes or for truck fleets, drilling fleets, or back to the electric grid. Any excess gas will be burned through an ECD and Ward plans on using an ECD that will eliminate any noise issues. A gas analysis from this well will be sent once the well is completed in early June 2016.
