#### COMMENTS:

Noble Energy Inc. respectfully requests to change the casing plans for this well to create a monobore. The BHL, SHL, Top of Producing Zone, and Spacing Unit will not change. Noble will deepen surface casing to 1,850'. This will cover the base of the Pierre Aquifer for OBM considerations. Surface cement will be 629 sx of 14.2 ppg 1.5 ft3/sk. No intermediate casing will be ran. The production string will be:

- Hole size will be 8-1/2"
- 5-1/2" 20# P-110IC BTC casing from TD to surface.
- 1745 total sx of 12 ppg 1.81 ft3/sk lead & 13 ppg 1.87 ft3/sk tail.

Oil Based Mud will be planned for the production hole interval only.
