Noble Energy intends to permit this well as a monobore. The surface casing is set to 1,850' to cover the base of the Perre Aquifer for OBM considerations. Surface cement will be 535 sx of 13.5 ppg 1.70 ft3/sk slurry. No intermediate casing will be ran.

The production string will be:

- Hole size will be 8-1/2"
 - 5-1/2" 20# P-110IC BTC casing from TD to surface
 - 453 sx of 12.0 ppg 1.80 ft3/sk lead and 1218 sx of 13.0 ppg 1.90 ft3/sk tail
- Oil based mud will be planned for the production hole interval only.
