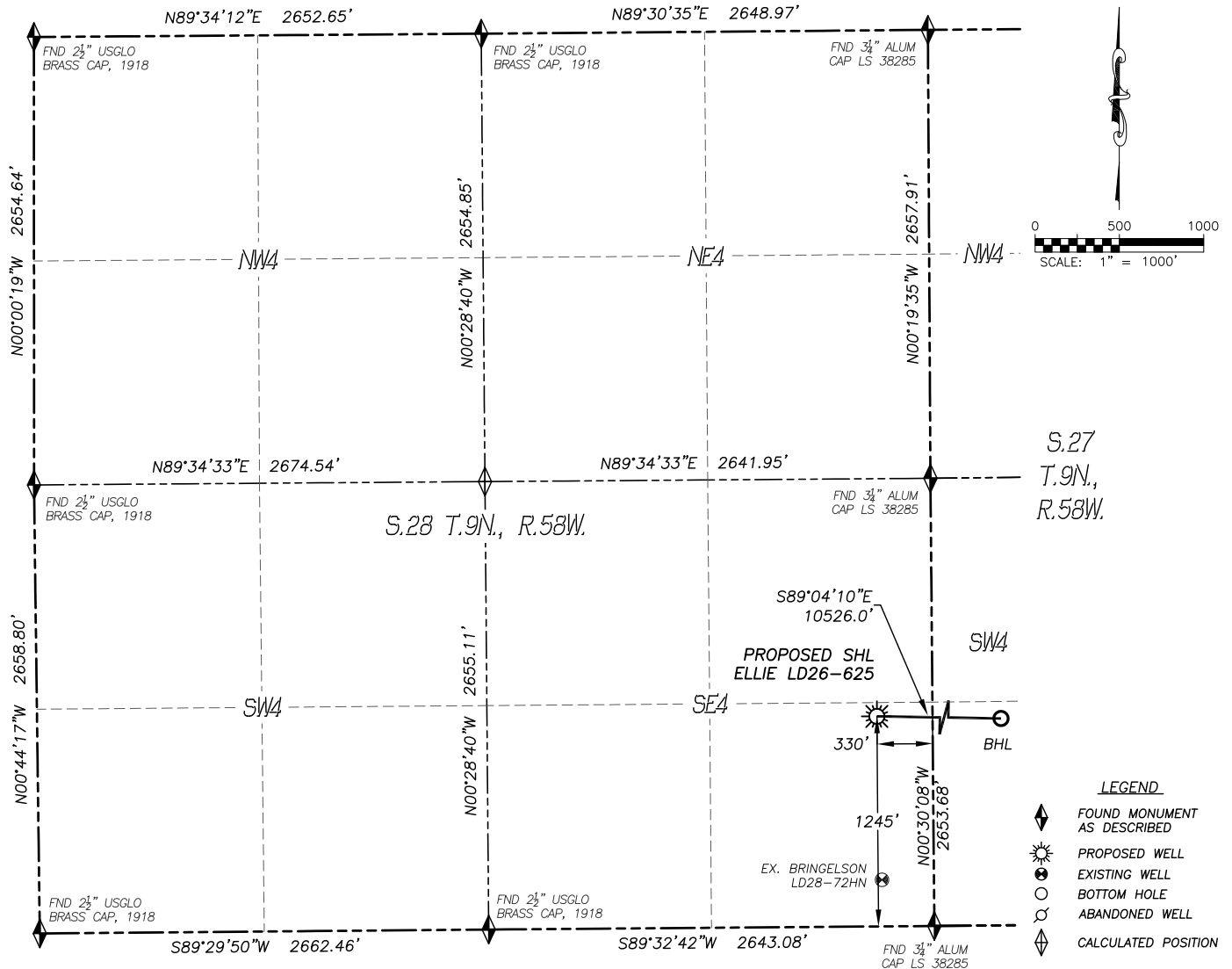

HAS DETERMINED THE SURFACE LOCATION OF THE ELLIE LD26-625 WELL TO BE 1245' FSL, 330' FEL, AS MEASURED AT NINETY (90) DEGREES FROM THE SECTION LINES OF SECTION 28, TOWNSHIP 9 NORTH, RANGE 58 WEST, AND THE BOTTOM HOLE LOCATION TO BE 990' FSL, 330' FEL, AS MEASURED AT NINETY (90) DEGREES FROM THE SECTION LINES OF SECTION 26, TOWNSHIP 9 NORTH, RANGE 58 WEST, OF THE 6TH PRINCIPAL MERIDIAN, WELD COUNTY, COLORADO.

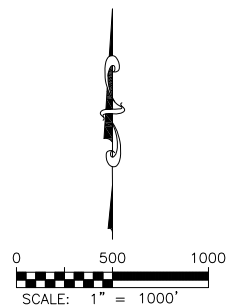

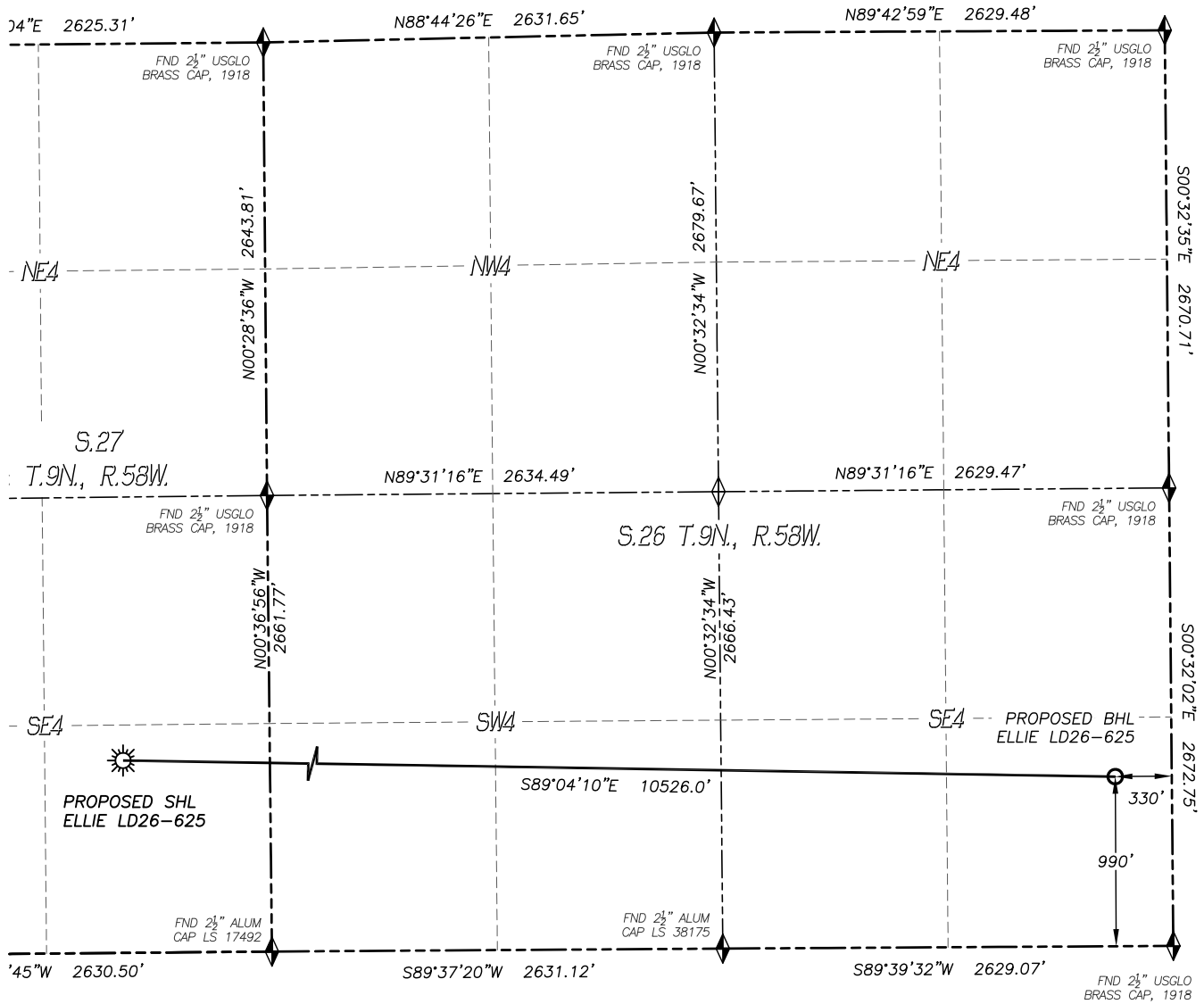
