## OPERATOR COMMENTS AND SUBMITTAL

Comments This is an amendment to Location ID 331830 to add one (1) VOC Combustor and one (1) separator. Noble will be installing an above ground VOC line which will block the current area between the VOC burner and the tank used for oil hauler turn around. Noble and Surface Owner agree to the expansion of the turnaround to the outside of the tank battery.

1 well located within disturbance area - National Hog Farms 24-21 (API# 05-123-21363)

Existing Equipment includes: One (1) well, one (1) oil tank, one (1) separator, one (1) VOC combustor, one (1) buried produced water vault. Total Equipment includes: One (1) well, one (1) oil tank, two (2) separators, two (2) VOC combustors, one (1) buried produced water vault.

No drilling will take place, therefore Drilling Program and Drilling Waste Management Program sections left blank.

The facility footprint will be increased by approximately 0.25 acre, south and east of location. A VOC burner, associated above-ground VOC lines, and a separator will be added to location. Wetlands are mapped via the Hydrology Map and COGC GIS East, South, and West of location. However the increased surface disturbance is minimal and will not affect wetlands. The surface owner has recently cultivated the area surrounding the location, and there are no indications of wetlands. Based on desktop analysis wetlands will not be affected by construction activities.

Cleanup of trash and discarded materials will be conducted at the end of each work day. These materials will be disposed of properly.
2	Storm Water/Erosion Control	Stormwater management plans (SWMP) are in place to address construction, drilling and operations associated with Oil & Gas development throughout the state of Colorado in accordance with Colorado Department of Public Health and Environment (CDPHE) General Permit No. COR- 038637. BMP's will be constructed around the perimeter of the site prior to, or at the beginning of construction. BMP's used will vary according to the location, and will remain in place and maintained until the pad reaches final reclamation.
3	Material Handling and Spill Prevention	Spill Prevention Control and Countermeasures (SPCC) plans are in place to address any possible spill associated with Oil & Gas operations throughout the state of Colorado in accordance with CFR 112.
