#### COMMENTS:

Bonanza respectfully requests approval to flare the subject well for 7 days by producing the well directly to a temporary frac tank. The estimated total volume we anticipate flaring is 450 Mscf. The subject well is located in a flood zone and there is no infrastructure on location to produce the gas. Bonanza estimates it would cost roughly \$70,000.00 in capital to connect this well. This well has an average flow rate of 6 Mscf/hr which does not generate an adequate payout to warrant this investment at this point in time. Bonanza has complied with all site specific permitting required by the Colorado Department of Public Health and Environment, Air Pollution Control Commission (CDPHE) regulations as set forth in 805. b. (1). A representative gas analysis for this well is attached from the Perkins wells which produce from the same formation and are nearby.
