

**WELL ABANDONMENT REPORT**

The approved intent shall be valid for six months after the approval date, after that period, a new intent will be required. Attachments required with the Intent to Abandon are wellbore diagrams of the current configuration and the proposed configuration with plugs set. A Subsequent Report of Abandonment shall indicate the actual work completed. Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

3. TIH with tubing. Sting into retainer and pump 100 sxs of 15.8#/gal CI G cement. Displace cement to top of retainer. Sting out of retainer.
4. TIH with casing cutter. Cut 4 1/2" casing at 920'. Recover 4 1/2" casing.
5. TIH with tubing to 970'. Mix and pump 380 sxs of 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
6. Cut surface casing 6' below ground level and weld on cap.
