Operator Comments:

GRMR requests confidential status for 6 months from the date of completion. GRMR is requesting confidential status on these wells in the existing Waddle Creek field due to the nature of several factors:

- 1) Though this field has existing Niobrara production, the mode of exploration and development is based solely on proprietary seismic information. GRMR feels that if this trend is observed by offset operators or competitors, we would lose our competitive advantage in future land leasing or seismic acquisition rights.
- 2) Because of the faulted/fractured nature of this play, GRMR is required to drill these wells at a high angle and underbalanced. We feel this also gives us a decisive competitive economic advantage in the area.
- 3) GRMR is not cementing our production casing in place, which allows for oil to travel from the fractures to the wellbore and allows us to potentially deepen the wells in the future. This is a very unconventional completion concept that we would prefer to test further before fully understanding the benefits of this method.
