This pad inadvertently was built to 2.7 acres due to the additional cuts for construction. The pad was reviewed on-site by the COGCC, Colorado Parks & Wildlife, and Archuleta County at the time the Wright 21-1 was drilled, and again on 6/2014 when Dakota 21-3 well was drilled. Both onsites showed there will be no adverse impact to the public health, environment, water sources, public safety and Wildlife.
