COMMENTS:

PRM requests approval to remove the drill cuttings from the cuttings pit and spread them over a portion of the well pad to dry them before burial in the cuttings pit. Over the winter the cuttings pit filled with snow and the cuttings are wet. The attached plat shows the proposed cuttings drying area on the south side of the well pad (against the cut wall). A containment berm will be placed around most of the proposed cuttings drying area except along the cut wall of the well pad. The existing stormwater ditch will be moved to immediately north of the new berm containing the cuttings drying area to direct stormwater runoff to the existing stormwater catch basin. The cuttings will be sampled and tested to ensure that they meet the COGCC Table 910 standard before burial in the cuttings pit.

The cuttings are from the single vertical well drilled last winter and the volume is estimated to be approximately 500 cubic yards.
