WPX Energy Rocky Mountain, LLC respectfully reports the following completed work to remove/replace damaged joints of casing in the Federal RGU 32-26-198 well.

##### PROCEDURE:

1. Diagnosed damaged casing to approximate depth of 580'
2. Set cement plug to kill well
3. Bleed off pressure
4. Tear down wellhead
5. Nipple up BOP
6. Fish damaged casing to collar at 604'
  - a. Replace damaged casing joints (580') with new 4-1/2", 11.6 #/FT, P-110, LT&C
7. Run caliper log
8. Reinstall wellhead
  - a. Pressure test wellhead - Passed
9. Pressure tested casing to 4300 psi
  - a. Passed pressure test
10. Drillout cement plug
11. Land Tubing
12. Install wellhead flange
13. Put well on production
