## COMMENTS:

Whiting Oil and Gas Corporation (Whiting) is requesting approval to backfill the pit excavated at the Federal 8-6, utilizing the stockpiled soil for the backfill material. The analytical data, as summarized in the attached Tables, indicate that the proposed backfill materials meet the applicable Table 910-1 limits, with appropriate consideration given to the background soil analytical data from this field. The analytical data also indicate that the excavation sidewalls and bottom also meet the applicable Table 910-1 limits. Laboratory analyses were conducted by the ALS Laboratories in Kelso, Washington and Holland, Michigan, based on laboratory availability.

Whiting will plan to submit a final report to the COGCC following site backfill activities, and seek to close out the remediation project at that time.
