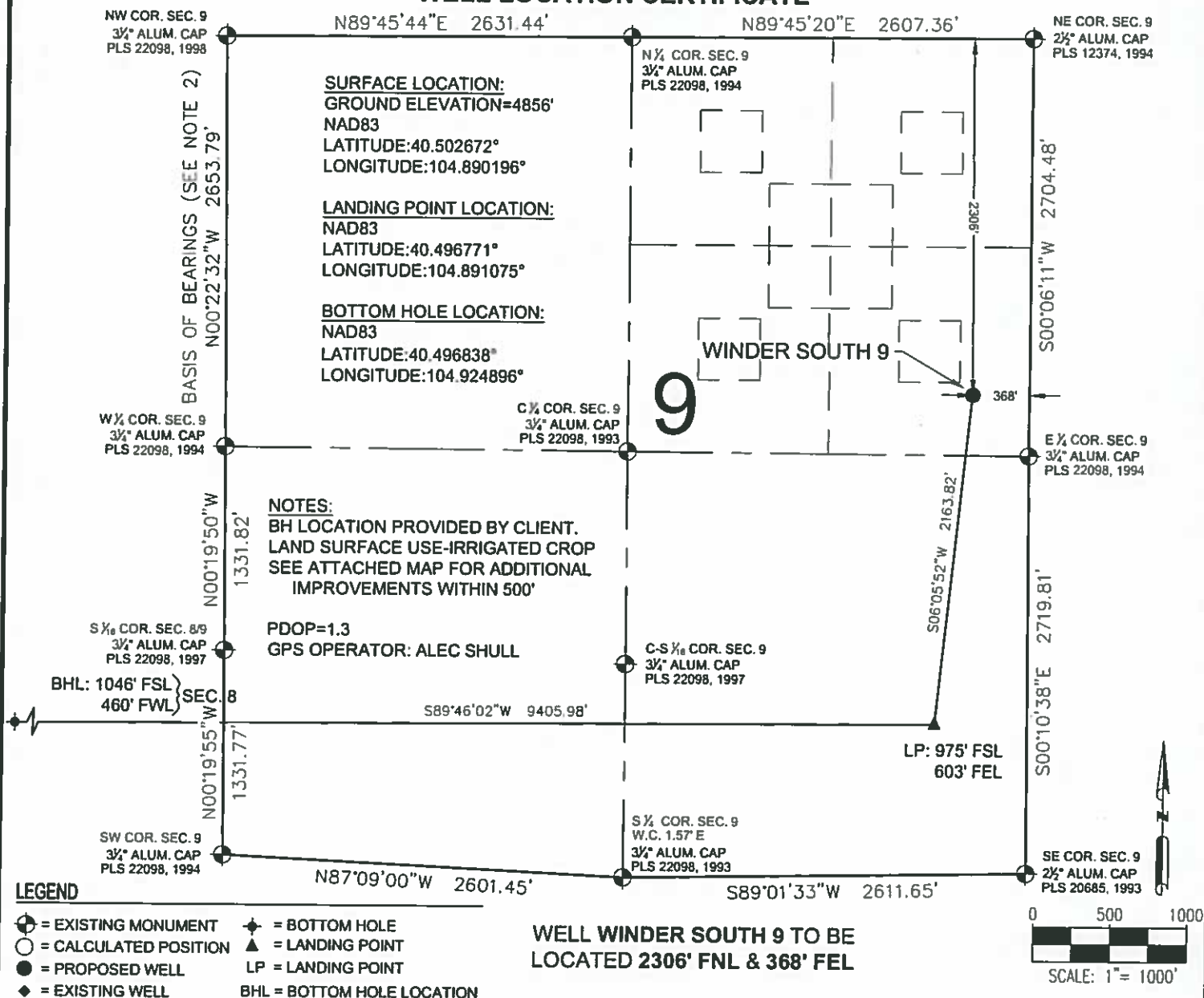


WINDER SOUTH 9 WELL LOCATION CERTIFICATE

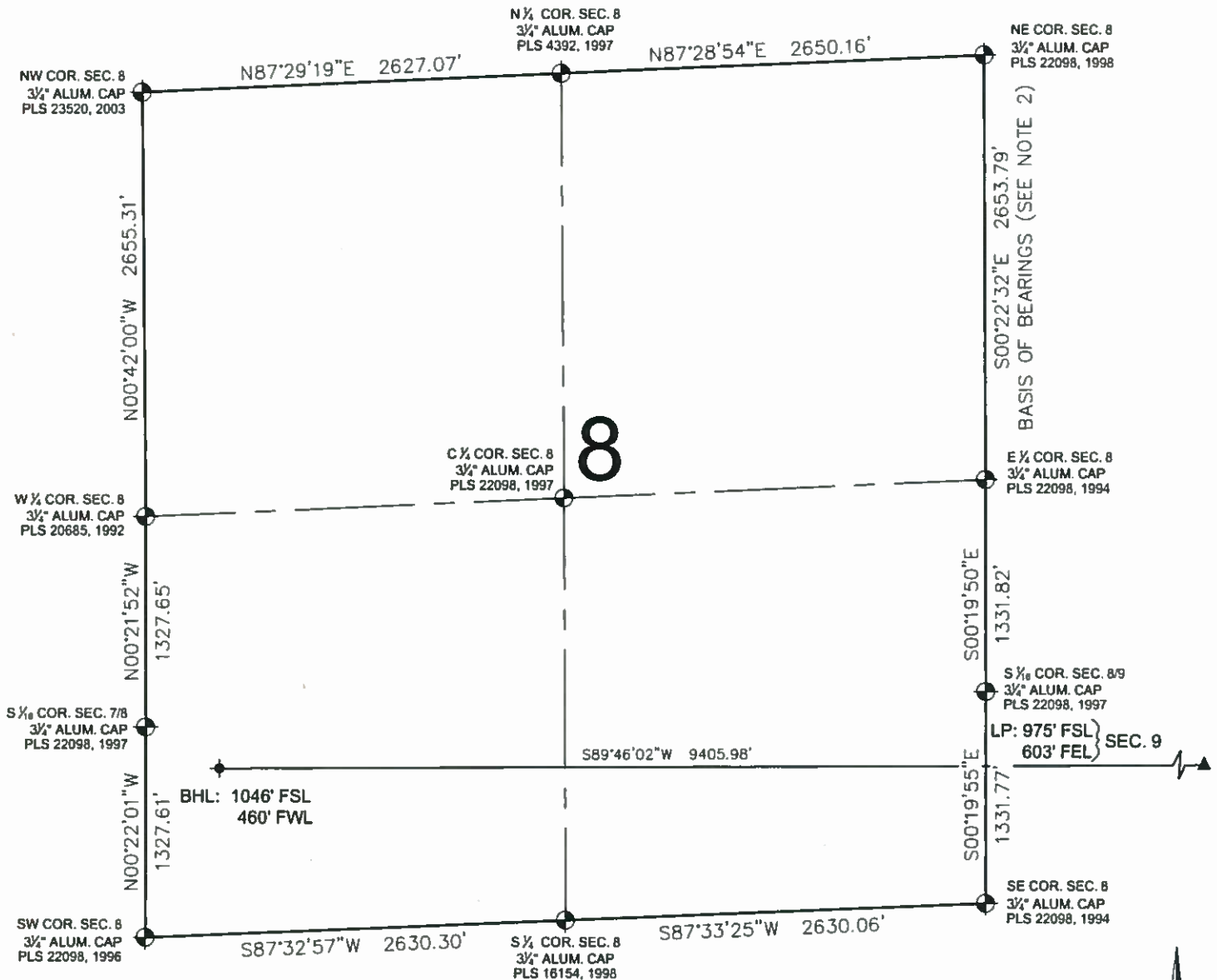
