Caerus Piceance LLC (Caerus) plans to file an application with the Colorado Oil and Gas Conservation Commission "COGCC" to drill a water disposal well in the captioned location. This application is part of Caerus' effort to handle water disposal in the area more efficiently.

In accordance with the rules and regulations of the COGCC, this letter gives notice to the surface and mineral owners within a 1/4 mile radius of this well. The dedicated water injection well will target the Ohio Creek conglomerate of the Hunter Canyon formation of the Mesaverde Group as the objective disposal interval.

If you feel you would be directly and adversely affected or aggrieved by the authorization of the underground disposal into the proposed injection zone you may file written objection to the COGCC within fifteen days of receipt of this letter, provided such objection meets the protest requirements specified in subparagraph m. of Rule 325. Additional information on the operation of the proposed disposal well may be obtained at the COGCC Office.
