Dear Director Lepore:

Pursuant to Rule 502.b(1), please be advised Kerr-McGee Oil and Gas Onshore LLC (KMG) hereby requests that the COGCC grant a variance of Rule 318A.e(5)B. in regard to the notice requirement that, "Each owner shall have a 30 day period after receipt of such notice to object in writing to the operator."

A notice was mailed to each Working Interest owner (WI) on May 27, 2016. In trying to comply with this regulation KMG has encountered circumstances to which KMG believes were not intended to be an issue in permitting wells. Those circumstances include several unleased mineral owners (who are technically WI owners) whom KMG has made best efforts to notify, but for reasons beyond our control, either 1) are no longer at the address of record; 2) the post office is unable to deliver because there is no one at the address of record; 3) for reasons unknown the working interest owner has not or will not pick up their notice. The Working Interest owners that this variance apply to are very small interest owners under small lots or tracts within the spacing unit being applied for.

SUMMARY OF STATUS OF WORKING INTEREST OWNER’S NOTICES:

The total number of Working Interest owners who were sent notices for the spacing unit referenced above is 14.


For your convenience we have attached a spreadsheet of all owners and the results of our attempts to notify.

KMG believes this request complies with Rule 502 b.(1) as it states, “*The operator or the applicant requesting the variance shall make a showing that it has made a good faith effort to comply, or is unable to comply with the specific requirements contained in the rules, regulations, or orders from which it seeks a variance, including, without limitation, securing a waiver or an exception, if any, and that the requested variance will not violate the basic intent of the Oil and Gas Conservation Act.*” KMG would like to request this variance for relief from the requirement to provide notice to the owners.
