COMMENTS:

Permission requested to flare Bradenhead gas in a quantity that is too small to measure. Well builds bradenhead pressure over a period of 7 days but it blows down in seconds to an imperceptible flow rate. Plan is as follows:

1. Install a Solar Spark Passive Vent Flare at >75' from wellhead.
 2. Allow bradenhad gas to flow to the flare unit, which has a solar powered continuous ignition system.
 3. Operate on a flow cycle of three weeks of flow followed by one week of shut-in.
 4. Maintain records of maximum shut in pressure.
 5. Review data with COGCC Engineering at 12 cycles and 24 cycles or until pressure no longer builds up.
- Note: Due to the small quantities, emissions are expected to be near zero.
