#### COMMENTS:

This well has been drilled, completed and is now producing. SandRidge E&P respectfully requests the right to flare due to several circumstances: 1. The closest/most practical pipeline tie-in point is over 100 miles away. 2. Construction of pipeline to said tie-in point will take over a year to obtain ROW, permits and construct along with costing over 50 million. SandRidge has though started this process to construct this gathering pipeline reach to market tie-in. 3. ~200-300 mcf/d will be flared for the first year then decline. BTU content of the gas is 1457 (real dry gas) and 1431 (water saturated gas) H2S = 0 ppm - analysis attached. 4. SandRidge has compiled with Rule 805 b. (1.) 5. SandRidge will use CDPHE approved flaring method. SandRidge has an "in-house" air compliance team and has a local, Colorado based air/environmental advisory company to assist with monitoring of air & environmental compliance.
