THE MAMA BEAR 1-1 IS ON SAME PAD SITE AS MAMA BEAR 1-1B (REFER TO ATTACHED IMAGE FROM GOOGLE EARTH- THE LAT/LONG PLACEMARK IS THE LOCATION OF MAMA BEAR 1-1). RECLAMATION OF THE ENTIRE SITE WILL BE COVERED WHEN THE MAMA BEAR 1-1B IS EVENTUALLY PLUGGED. WE THEREFORE REQUEST THAT THE MAMA BEAR 1-1 BE REMOVED FROM OUR BOND. ALSO OUR LANDMAN, WHO KEPT OUR LAND FILES/AGREEMENTS, ETC., IS NO LONGER IN BUSINESS AND CAN'T FIND THE SUA. WE HAVE ATTACHED THE SURFACE CONSULT LETTER WHEREIN MR DUNIVAN MET WITH OUR REP AND WAS SATISFIED WITH THE LOCATION.
