COMMENTS:

Routine UIC inspection and SCADA hi/low automated shut down demonstration and test. Injection well was shut down three times as injection well kills settings were tested. The tubing high pressure kill is set for 1250 PSI. When tested the injection pump shutdown when tubing pressure exceeded 1250 PSI. The tubing low pressure kill is set for 300 PSI. When tested the injection pump shut down when pressure fell below 300 PSI. The casing high pressure kill is set at 400 PSI. When tested the injection pump shutdown when casing pressure exceeded 400 PSI. All three tests were successful as injection pump shut down at preset limits as required.
