**CONDITIONS OF APPROVAL, IF ANY:****COA Type****Description**

Land application of drilling fluids and cuttings at the location was terminated by the operator on or around March 12, 2015. Sampling & analysis provided by the operator demonstrates compliance with Table 910-1 thresholds and local background concentrations. All fluids and cuttings have been incorporated into native soils. Site was inspected by COGCC environmental staff in June 2016 (doc 679400024) and site conditions for closure were satisfactory with submission of a final closure report (this submittal).

PDC has demonstrated that the facility meets the environmental closure requirements; however, the facility will remain "Active" status until a final reclamation review has been performed. A sundry notice request for final reclamation review of the site should be entered to trigger the reclamation review.
