All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.

Permit	The current spacing order(531-23) does not permit the completed portion of the wellbore to be closer than 300' from a unit boundary and this well is proposed within 100' of a unit boundary. The requested spacing order to allow the completed wellbore within 100' of a proposed boundary is on the July docket#160700284. Permit	Reviewing. The Deviated Drilling Plan is missing adequate coordinate data.	6/24/2016 1:14:00 PM
Engineer	Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location. This information was used in addition to locally-available geophysical logs and hydrogeologic information to evaluate the adequacy of the operator's proposed surface casing setting depth. The deepest water well within one mile is 150 feet. The Coalmont Formation is considered a potential freshwater resource in the North Park Basin (CGS Ground Water Atlas of Colorado, 2003). The proposed surface casing setting depth of 2500' will not cover the entire Coalmont Formation, based on the operator's drilling prognosis in the drilling plan. Minimum cement isolation standards are specified in Condition of Approval #2. Offset Well Evaluation: Offset wells within 1,500 feet of the wellbores planned on this pad are two wells with a status of drilling at the time of this review. The wells will meet standards if constructed as permitted. No mitigation required.
