#### COMMENTS:

This sundry is being submitted in response to an Action Required inspection notice (doc #682400905) which requested action on the two items below.

- 1) Removal of weeds by 7/29/16 - BBC contacted the surface owner to notify them of spraying and was advised that the tenant farmer had sprayed this location and surrounding area on 7/22/16 and BBC then removed the weeds. BBC will continue to monitor the oil and gas location and work with the surface owner and tenant farmer on additional spraying/weed removal.
- 2) Provide reclamation schedule - BBC will be meeting with the landowner and the landowner's tenant farmer during the week of August 1, 2016 to discuss final land use for this location given initial discussions on change of use. If the surface owner wants BBC to remove the remaining road base and reseed this location, BBC will remove the road base and reduce compaction of the site by August 30, 2016 and will seed the location when weather conditions are conducive in the fall of 2016. Seeding will be completed no later than October 31, 2016. If the surface owner requests a waiver to reclamation requirements based on a change to the current land use, BBC will work with the surface owner to prepare the necessary waiver and variance documentation for submittal.
