Dear Gene Carlson,

Bill Barrett Corporation ("BBC") is planning to drill oil wells on the above mentioned well pad. Rule 305.a(2) of the Colorado Oil and Gas Conservation Commission's Rules and Regulations requires that BBC provide a "Notice of Intent to Conduct Oil and Gas Operations" to all Surface Owners and Building Unit Owners within the 1000 foot Buffer Zone. A recent field survey indicates that your residence (i.e., Building Unit) is located approximately 834 feet from the nearest well on BBC's proposed CVR 5-63-32_33 NWSW well pad. You may request a meeting to discuss the proposed operations by contacting the LGD or Operator (BBC).

A Notice of Comment Period will be sent pursuant to Rule 305.c(2) when the public comment period commences.


