Noble Energy respectfully request continued TA status. The well is closed to the atmosphere via a RBP bridge plug set at 6856' on 1/3/2016 for an off-set frac. Noble will return the well to production once the off-set frac is complete and a rig is available. Noble will run an MIT if the well is still TA'd after two years. Attached is the initial pressure documentation. The well shut-in and locked out and tagged out at the master valve.
