The bradenhead on the subject well was tied to the production/sales line downstream of the wellhead and upstream of the meter skid using stainless steel tubing. A one way check valve was placed in the line between the bradenhead and the production/sales line to prevent flow from the production/sales line back into the bradenhead. Please see the attached photograph showing the tie-in.
