This Form 4, Sundry Notice is submitted in response to the Field Inspection Form dated July 12, 2016 (Document No. 673503491). That Form directs Pine Ridge to submit a Sundry Notice regarding final reclamation of the location by July 26, 2016. After the Bull 42-4 Well was plugged and abandoned, the Location was converted to a Contractor's Yard. This use of the location was authorized by the surface owner in 2010 and approved by the Fremont County Department of Planning & Zoning in 2011. This facility was conveyed to Incremental Oil & Gas (Florence), LLC (Colorado Operator #10417) in April 2012. Since that time, Pine Ridge has had no interest in or other involvement with the location. Pine Ridge intends to submit a Variance Request under Rule 502.b and Rule 1001.c from the final reclamation requirements. Pine Ridge requests that the Commission provides adequate time for that to be assembled.
