Proposed Well Patch Procedure:

1. Notify COGCC, BLM 48 hrs prior to start of activity via electronic Form 42
2. Run tubing to 1,730' prep to pump balance plug
3. Pump 35 sks 15.8 PPG Class G Cement balance plug to 1,268'
4. Squeeze cement to max psi of 4,000 psi
5. Shut well in for 24 hrs
6. Drillout out estimated 462' cement plug
7. Psi test casing to 2,500 psi for 15 mins
8. Rig up Cutters Wireline Service run in Owens patch set at 1700' (10' Patch)
9. Psi test casing to 4,000 psi for 15 mins with rig equipment
10. Nipple up frac stack and psi test to 7,200 psi for 30 mins
