COMMENTS:

The Burr FD 23-299HN bradenhead has started to build pressure. We would like to perform an initial Bradenhead test (Form 17) and then leave open for 3 weeks, and then perform another Bradenhead Test Form 17 after a 7 day buildup. Repeat this process for up to three cycles (approx 90 days total). At the conclusion of the cycles the Bradenhead Test results will be reviewed and a recommendation will be drafted.

Background:

All wells on this pad were spud (surface pre-sets) 10/28/15 to 11/4/2015. Pressure tested and frac'd in April and May of 2016. Drilled out and put online mid June 2016. There was little to no pressure on the bradenheads prior to, during, or after frac/drill out. A few weeks after putting online the well started to build pressure on the bradenhead.
