2. RU wireline company.
3. TIH with CIBP. Set CIBP at 7283'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set CIBP at 7040'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 600'. Recover 4 1/2" casing.
6. TIH with tubing to 650'. Mix and pump 280 sxs of 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
