COMMENTS:

Cuttings associated with the Ray Ranch 0780 3-16H and 4-16H wells were initially sampled and analyzed for the Table 910-1 analytes except boron pursuant to SandRidge's E&P Waste Management Plan which was approved by the COGCC on June 22, 2016.

Based on the analytical results, all analyte concentrations met those established in Table 910-1 except for pH. With respect to pH, the results reflected a value of 9.90 SU which was outside the Table 910-1 pH range of 6-9 SU. However, subsequent pH analysis of the cuttings that have since been blended with a drying agent (i.e. Hydro Loc) were performed, the results of which reflect a pH of 8.56 SU which is within the aforementioned range. A copy of the analytical results are attached.

In light of these most recent results, SandRidge now intends to beneficially reuse the cuttings in accordance with the approved E&P Waste Management Plan.
