For the most part I await COGCC approval and once the COAs come out I send them along to the BLM. In the field direction is crucial as well I suppose.

Kerry,

I can extend the expiration without resubmittal. We have been adding a new COA on BLM wells:

- 1) This well has federal minerals. Operator shall notify COGCC engineering staff of any plugging changes required by BLM prior to plugging or in the field.

The intent of this is to make it easier to make changes in the field on BLM lands and to make sure we don't have conflicting conditions on our Form 6 and the BLM plugging sundry. You can call when you get back to cell phone service if the BLM requires a change in the field. If Maralex agrees to the add the COA above I will extend the expiration dates on these Form 6 NOI's for 6 months and document in our well files.

I don't think you need an extension on Rifle Walton 25-2.
