Monday (8/22) at approximately 11:20 am a release occurred from a drained 2" fiberglass line that was being washed with fresh water prior to being capped to be put out of service at Carney 41Y34 (API 05-103-06149) Approximately 60 bbls of potable rinse water and 0.01 bbls of oil were released. Approximately 30 BBLS of water was recovered, and all the oil was recovered. The flush was stopped immediately upon detection. The oil affected area has been water washed. The line will remain out of service until repaired.
