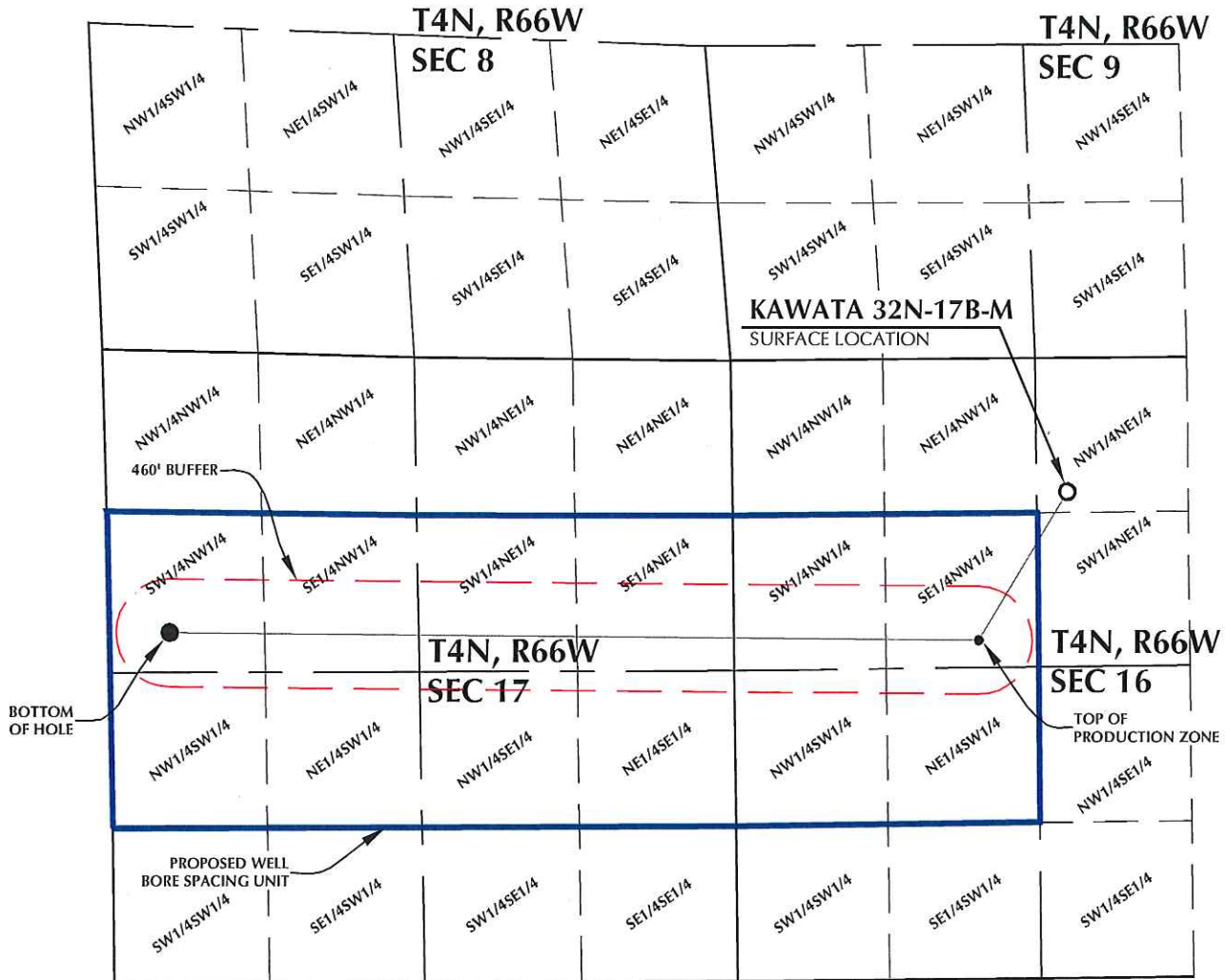

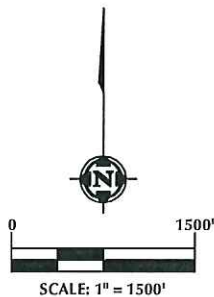
KAWATA 32N-17B-M WELL BORE SPACING UNIT
