Peter, we have a crew ready to perform the cleanup. We also have our land group attempting to contact the landowner to get permission. Once the approval has been acquired, we will initiate cleanup. It also appears that stormwater from our centralized E&P Waste Management facility in neighboring SW 34 3N 66W also overflowed the berm and is contributing to the heavy flow. The berms at this facility are intact. This facility is referred to as our Drilling Fluid Management Facility (DFMF) #1. I will follow up once cleanup is completed.
