Environmental	<p>COGCC staff has reviewed the document attached to the e-form 04 doc #401115283 and agree with the request that removal of the soil impacted by the leaking tank identified above be considered complete. Please back fill the excavation and when the work is completed submit a supplemental Form 19 requesting closure (to close the Spill report).</p> <p>The COGCC concurs with Caerus that a drilling pit existed immediately to the South of the current excavation. The pit was used in 2007 and was back filled shortly thereafter. COGCC Rules at the time (before the 2009 Rules) required that drilling pits be back filled and did not require sampling.
