Gulfport Energy Corporation respectfully requests continued flaring for the State 33-15 due to the lack of gathering systems, increased development or new pipeline that would allow the capture and sale of gas. The conditions remain such that it would be uneconomic to construct such facilities.

The estimated volume of gas flared for 2015 was 48.64 MMscf.

Gulfport Energy is in compliance with Rule 805.b.(1).

Gulfport Energy will use a CDPHE approved flaring method and any site-specific permitting required by the CDPHE.
